Pass Holder has to show Bus Pass to any competent officers/checking officials of the Corporation on demand, if fails to do so he/she has to pay the penalty as per rule. 9. Corporation will neither issue duplicate pass nor refund proportionate fare in case of partial/complete damage, mutilation or loss of Bus Pass. The cost of Refunded Ticket is ₹ 10/-per refund.
